




CORE	Structural Composite Lumber (SCL)
VERTICAL EDGES (STILES)	Maple with matching removable vinyl or stainless steel removable edge
HORIZONTAL EDGES (TOP & BOTTOM RAILS)	Structural Composite Lumber (SCL) sealed top & bottom rails
FACES	Inpro Rigid Vinyl
CROSSBANDS	High Density Fiberboard (HDF), 20% of door construction weight, pre- consumer recycled material
STANDARD BEVEL	1/8" in 2" or 3°
FINISH	Woodgrains, solid colors, & elements
ADHESIVE	Type 1 adhesive
FACTORY MACHINING	All cutouts for mortise hardware should be made at the factory from hardware manufacturer's templates & approved shop drawings

ADDITIONAL DOOR FEATURES & STANDARDS

CUTOUTS: 5" minimum distance from door edge & the minimum distance between lite & lock cut out is 1-1/2" non-rated & 20-minute

CLEARANCES: 1/8" top, 1/8" lock & hinge stiles. See NFPA-80 6.3.1.7.1. Bottom clearance 3/4" max (bottom of the door to top finish floor) See NFPA-80 4.8.4.1

SECURITY RATING: Class 40, ASTM 476 (highest rating possible)

LABELING: Positive pressure, Category A 20-minute Intertek/Warnock Hersey fire labels shall be available within size & usage approvals. Fire-rated doors must use approved lite frames. UL 10C

PACKAGING: Doors shall be individually poly-bagged for protection & marked as per tag openings on shop drawings

ACCESSORIES: Door bottoms, sweeps, thresholds, gasketing, lite kits & glass may be supplied by VT or others
